Subject: Electronic Stickers (House Bill 679)

Last August, the North Carolina General Assembly passed House Bill 679, which synchronizes the issuance of inspection stickers and vehicle registration stickers. This new law becomes effective October 1, 2008. In preparation for the major changes DMV must make in the safety inspection program, all licensed safety inspection stations are required to have station managers or owners attend a meeting about the new program. Several meetings have been scheduled to provide you with the information necessary to continue operating as a North Carolina-licensed inspection station. The dates, locations and enrollment instructions for these important educational meetings are attached. Please plan to attend the meeting indicated for your area.
