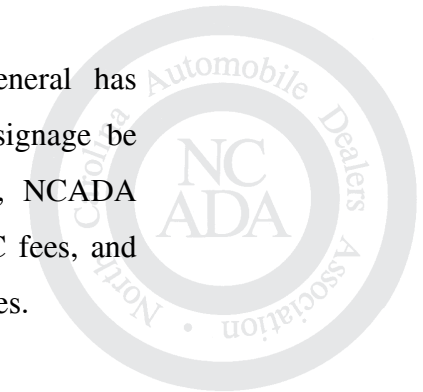

Fee Disclosure Requirements

State law requires dealers to post signs at the dealership to conspicuously disclose information concerning documentary or administrative fees as well as compensation for dealer-arranged financing. The purpose of the law is to make consumers aware of fees that may be charged as a part of the business transaction. The law does not place a limit on the amount of such fees; it only requires that certain information about the fees be disclosed in a particular manner.
